The high foaming detergents suspend the soils in solution once removed from the surface. DIRECTIONS FOR USE:

Shower and Wash Basins	Apply a small amount to an area and scrub using a scouring pad to aid in the easy removal of soap scum.
Toilet Bowls	Invert the special applicator and apply under the rim of the bowl or urinal allowing the product to run into the bowl or urinal. Leave for a minimum of 10 minutes before flushing the toilet. (Scrub with brush for heavy stains.)
Floors and Walls Dilute	50mL/Litre of water
